Only competitors in Adult Division can compete for the MO State Fair Homegrown Singer Contest. The State Fair Homegrown Singer Contest is a vocal competition. See notes below. The highest placing vocal competitor from the talent show who has indicated that they interested in the Homegrown Singer Contest will represent Howard County at the Missouri State Fair.

___ Yes, I am in the Adult Division and wish to compete for Homegrown Singer Contest

For the adult division, the preliminary to the Missouri State Fair Homegrown Singer Contest, entrants must be at least fifteen (15) years of age at time of contest entry. ***The highest placing competitor from the Howard County Fair Talent Show adult division who has indicated an interest may be automatically entered in the Missouri State Fair Homegrown Singer Contest preliminaries.*** If competing for Homegrown Singer Contest, the following guidelines also apply at the Howard County Fair:

Following are the guidelines for the adult division, Homegrown Singer. Length of competition is not to exceed 4 minutes; performer may sing a cappella, with an accompaniment CD, with one live stringed instrument accompanist, or with the performer playing a stringed instrument. No live background vocal assist is allowed (background vocals and music from the accompaniment CD are allowed); no explicit content/lyrics are allowed. Homegrown Singer Contestants should be prepared to sing up to two (2) songs. Regular Fair admission fee will be required to enter the fairgrounds. Contest rules and format are subject to change. Other rules and considerations will apply for the adult category winner to compete in the Missouri State Fair Homegrown Singer contest. Check the website mostatefair.com for more details.
